On March 17, 2020 Quadrant Real Estate Advisors LLC ("Quadrant") executed upon an agreement with an unrelated third-party investment advisor (the "Buyer") to sell the assets required to provide investment advisory services to three of its investment advisory clients (the "Transaction"). The Transaction involved a total of \$9,580,843,494 in Regulatory Assets Under Management with \$9,579,665,691 being two (2) non-discretionary insurance company single client accounts, the entire amount representing Commercial Mortgage Loans, B-Notes, Mezzanine Loans, and Construction to Permanent Loans secured by Commercial Real Estate and one (1) \$1,177,803 discretionary commingled fund. There was no leverage or derivatives on any of these accounts (NOTE: All figures as of December 31, 2019). The Transaction also provided for the Buyer to hire twenty four (24) of the employees of Quadrant necessary to provide such services (the "Lift Out Team"). Five (5) of the twenty four (24) employees included in the Lift Out Team were also members of the Board of Directors and officers of Quadrant Real Estate Advisors and Member/Managers of QCP, LLC. Each of these five individuals relinquished their seats on the Board, their roles and titles as part of the Management Team and their ownership in QCP, LLC effective March 17, 2020. Finally, the Transaction provided for the Buyer to assume certain third-party service provider contracts necessary to perform the investment advisory services for the three clients (including the lease at 2735 Morris Road, Suite 100; Alpharetta, GA 30004, the then current the US headquarters. The Company has relocated to 2300 Lakeview Parkway, Suite 225; Alpharetta, GA 30009. In order for the annual amendment to not be misleading, the form has been filed utilizing December 31, 2019 figures excluding the assets/employees included in the Transaction. It is understood that the acquiring Advisor is including those figures in its filing due March 30, 2020.
